I want to reflect for a moment on how I have experienced the Addison Pastoral Charge during the past year. I sense that the Church-at-large, of whatever denomination, denies itself the privilege very often of experiencing the Rural Church as it really is. We have tended to become so used to urban understandings of things that the Urban Church has become the standard against which we measure the health and vitality of our denomination. Sometimes even rural churches try to mimic urban churches. Not so with Addison United Church.

Addison, you have a vibrant ministry that does not rely on a large budget or expansive premises, but on the contact you have with the community around you and your down-to-earth approach to that calling. Money is important to keep things going, but it is not a constant worrisome pre-occupation. That is refreshing. Your willingness to experiment, to take responsibility as individuals for things you would normally have to pay a professional to do (such as lead worship from time to time), your very generous support of a variety of projects as well as the wider Mission and Service expectations of the United Church of Canada. All these things have encouraged and impressed me. You are realistic about what you can do, but that doesn't stop you from thinking outside the box, and that is like a breath of fresh air in a Church climate that has become pre-occupied with the gloomy prospect of dwindling numbers, and maybe even dying.

It has been a privilege to share this ministry with you during these past few months, and I would encourage you to keep experimenting and sharing your discoveries with others who are trying to be a vibrant Christian presence in the world . . . and keep planting those seeds (literally) and harvesting the blessings.

Wow, What a year! We are truly Blest!

The Addison Church in Action Team continues to work at being a green church. We continue to recycle used eyeglasses for poorer countries. We use our blue boxes extensively. We have a working composter. Our used battery sales did not pan out, but we still collect and donate them to another charity that gets enough to sell them.

Community Garden

Reverend Spivey's inspirational first sermon back in September 2014, on the lowly tomato seed has set seed and grew. Our Kitchen tomato plant continues to flower and produce tomatoes over 1 ½ years later. This seed blossomed into an idea for a community church garden in January 2015. The end result, through much discussion at Coffee Break, a donation of lumber, manpower, straw, manure, soil and outside community advice and plants, blossomed into 3 successful raised garden beds. The gardens produced onions, radish, cucumbers, tomatoes, beans (pole and wax), kale, carrots, beets, Swiss chard and strawberries. The gardens attracted much outside interest and a great many enjoyed the produce at Simple Fare, CPHC or Sunday lunch after church. We thank everyone who helped in the project including our Heavenly Father who provided the warmth of the sun, the rain for water (I think we only carried about 4 pails), the insects and the birds for pollination and pest removal.

Rural Coffee Break

Every Thursday is a weekly event that people from the community look forward to. There is no charge, only a donation to the coffee sack. We are proud of the exposure for rural ministry but more proud of the laughter, lively conversation and friendship of the people who come each week. Even Christmas Eve Thursday, we put the coffee pot on and our tables were full with people who wanted to get together for coffee and chat. We brew Fair Trade coffee and we sell directly to anyone interested in purchasing. The donuts that we serve are donated by Willard's Bakery in Athens are are really enjoyed by all. Coffee Break is not a fundraiser, but a partnership with the wider church of "people helping people".

Simple Fare Luncheon

This a free, nutritious lunch served on the third Thursday of the month. There is no charge to anyone to come and eat this meal. There is a donation jar off to the side if anyone wishes to donate. Any food remaining at 12:30 is packaged and given to people

within the community with special needs. People come from as far as Seeley's Bay, Smiths Falls, Toledo and everywhere in between to participate and to support this worthy cause. The food and fellowship go well together and everyone is welcome.

Summary

All the money from these two activities, after expenses, is given away. The donations have been divided around the local community, the Bay of Quinte Conference, Canada and South America. Total donations for 2015 amount is \$1777.00

The list is as follows: Athens Food Bank, Guatemala stove project, Syrian refugees through the Four Rivers Presbytery, Syrian refugee baby shower and daycare, New Start Program out of Newfoundland, Winter Warmth — Winnipeg Homeless Shelter, and Respond to Hunger in the North, Basic Needs — a Toronto Mission. The last four were taken from Gifts With Vision from the United Church of Canada.

We strive to make a positive difference in our little community and through Christ may we continue to serve and shine.

In partnership with The Pastoral Care Committee we continued with the knitting and crocheting of Prayer Shawls. Once again, the need was great and we were able to deliver 46 shawls in 2015.

Several of our ladies worked on a Food Catering Policy and brought their suggestions to our membership. This policy was approved.

We mourned the death of one of our Life Members - Kay Brady and were privileged to serve at her funeral reception.

Our catering events included 2 dinners for the Retired Teachers, the Rotary Club, a wedding reception, and another funeral reception.

As noted in our Financial Statement monies were given to the Church Council for the church signage, M&S and the church insurance.

Our Mothers' Day Tea and Fall Bazaar were very successful.

Several of our members attended the World Day of Prayer Service in March, the UCW Fall Rally in September and led a worship service in April.

Advent is always a busy month for our UCW. It began with a wonderful Christmas dinner. We certainly appreciated the work that Ray Bower and all the gentlemen in the kitchen did for us. Secret Pals were revealed that night and we gave the Food Bank our Sock Mountain of 227 pairs.

Our final event for the year was the packing and delivery of the Cheer Basket and floral arrangements. There is always a need in our community and we are only too happy to help fill part of that need.

We continued to collect stamps, Campbell soup labels, 300 milk sleeves for the MS Society, coordinated the delivery of 14,000 milk bags for sleeping mats around the world to a church who is still making them in Kemptville and preparing Friendship Bags. It has taken the efforts of many to make our UCW so successful. Thanks to everyone, including the men of our church family and those outside of our church. Let us learn from yesterday, live for today and hope for tomorrow and may we look forward to a successful 2016.

As the Addison appointed representative, I attended and actively participated in all full court meetings of Four Rivers Presbytery though out 2015. I reported back from these meetings to the Addison Council from February until December. I photocopied all Four Rivers Presbytery Executive and Full Court minutes and added them to the white binder in the church hall. I answer questions concerning the roles of Presbytery and of there decisions.

As a member of the Four Rivers Presbytery, it is our responsibility to share our talents on committees of the Presbytery. As such, I am on the Pastoral Relations Committee and also a team member for Pastoral Oversight visits. I attended two (2) Pastoral Oversight visits in 2015.

I attended the Bay of Quinte Conference "Back to the Future" in May in Wellington. The ideas from the basic principals of union will come the courage and strength to go forward with change. I reported back on the activities, discussions on church structure, choosing the representatives for the 49th General Council to be held in August in Corner Brooke Newfoundland and budget issues which were a large part of the three day event. I also spoke about how other Rural Churches are feeling and what they are saying.

As the Four Rivers Presbytery representative from the Addison Pastoral Charge, I continue to represent our church in the wider community. As such, I attended the Opening Doors to Generosity Event hosted by Ottawa Montreal Conference held in September in Cornwall. I reported back on the new language of Church Stewardship and how to better use resources available to us for M&S. I also attended the Fall Advance- a Stewardship gathering of the Bay of Quinte Conference in Belleville in October. These allowed Addison Pastoral Charge exposure to people from other Presbyteries within the Bay of Quinte Conference and beyond, giving them insight into who we really are and about our ministries. This is very important networking.

As the Presbytery Representative I attended four (4) Covenanting Services for Rev. Judith Evenden, Rev Arlyce Schiebout, and Lay Leaders Lillian MacName and Barb DeJeet.

A Congregational meeting was held Dec 7,2014 on where to invest the fund (~\$20,000) received from the separation of the Addison and Athens charge. It was agreed to invest with RBC in preferred shares because dividends were much higher than bank interest.

Update on Addison Church Investments as of Oct 19/2015:

The investments are split 50/50 between cash and cash equivalents and Fixed Income at \$27,640(Nov 30/2015). Total yield on fixed investment is currently is 4.5% with the total portfolio yield of 3.58%. Fixed investments which consist of preferred share which have a good yield as you can see BUT their current market value is down considerably. As long as the Church does not need these funds this is just a paper loss. If they are called by the Companies on maturity we get the \$25 /share that we paid for them thus not losing any \$ but have gained dividends over the life of the investment. The Church can take the monthly dividends as cash if needed.

A Trustees' meeting was held on October 25th informing members that A. Whitehorne resigned and an additional member was required. Rev Spivey was not available for the meeting.




